### INTRODUCTION




- In United States major accidents are being caused by drunk driving or other substance abuses.
- According to NHTSA data, a staggering 32 individuals each day, or one every 45 minutes, lose their lives in car accidents caused by drunk drivers in the United States (1).

- Mostly young drivers between the age of 16 and 20 are likely to involve in accident

#### **Other Physical Problems**


- Continuous drinking may left a person unconscious which could also result in fatal accidents.

## OTHER DRUGS AND DRIVING




- Alcohol, some legal and illicit drugs, and other substances can all have an effect on a person's ability to drive safely.
